- H. Approval of Fire Alarm Replacement Funded Mostly with Direct Appropriation Funds for (\$75,000) \$78,432 (Action)
  Jim Nessle motioned to approve the purchase of the fire alarm replacement utilizing the 5-year payout instead of direct appropriations, authorize an increase of 8% for a warranty, and authorize Jennifer Mercer to sign on the behalf of the school. Rachel Query seconded the motion. Council members unanimously approved.
