


## PICTURE DAY

#### **COVID-19 QUESTIONNAIRE**

(if you choose in-person learning)



Each day before sending your child to school, please review the following questions regarding your child's health.

If you answer yes to any of the questions:

Please do not send your child to school. Contact a medical provider or call the COVID Hotline at 855-600-3453, then call the health office at ECRA.

Questions for ECRA Students Before They Go to School

- 1. Does your child currently have a temperature of over 100.4 degrees?
- 2. In the past 24 hours, has your child experienced:
  - o Sore throat, runny nose, congestion
  - New frequent, dry cough (for students with documented chronic allergies/asthma, a change in baseline cough)
  - Shortness of breath or difficulty breathing
  - o Diarrhea, vomiting
  - Loss of taste or smell
  - New onset of headache
  - Fatigue or muscle or body aches
- 3. Has your child recently been in close contact with anyone who has exhibited any of these symptoms?
- 4. Has your child recently been in contact with anyone who has tested positive for COVID-19?

Reviewing these questions daily and making good decisions can help us prevent the spread of COVID-19.

#### COVID SURVEILLANCE TESTING



The state of NM has recommended that all families participate in regular COVID surveillance testing. This is especially important for students attending on campus activities or learning.

ECRA would like to encourage families to participate at least **once a month**. Please participate by week.

Week 1: last names starting with A-E,

Week 2: last names starting with F-L,

Week 3: last names starting with M-P,

Week 4: last names starting with Q-Z.

You may request a Vault link for testing at home.

Vault testing is a saliva test that you collect at home.

This is done while on a zoom call where a Vault employee observes the collection. The sample is then sent via UPS to get results.
