P-EBT ONETIME BENEFIT

The Human Service Department announced Tuesday that all New Mexico households receiving Pandemic Electronic Benefit Transfer (P-EBT) support would receive an additional, one-time payment on Aug. 8. The payment amounts to \$375 for each eligible student -- determined using a daily rate of \$6.82 for 55 days of summer. [This FAQ document answers additional questions about the P-EBT program.](#)

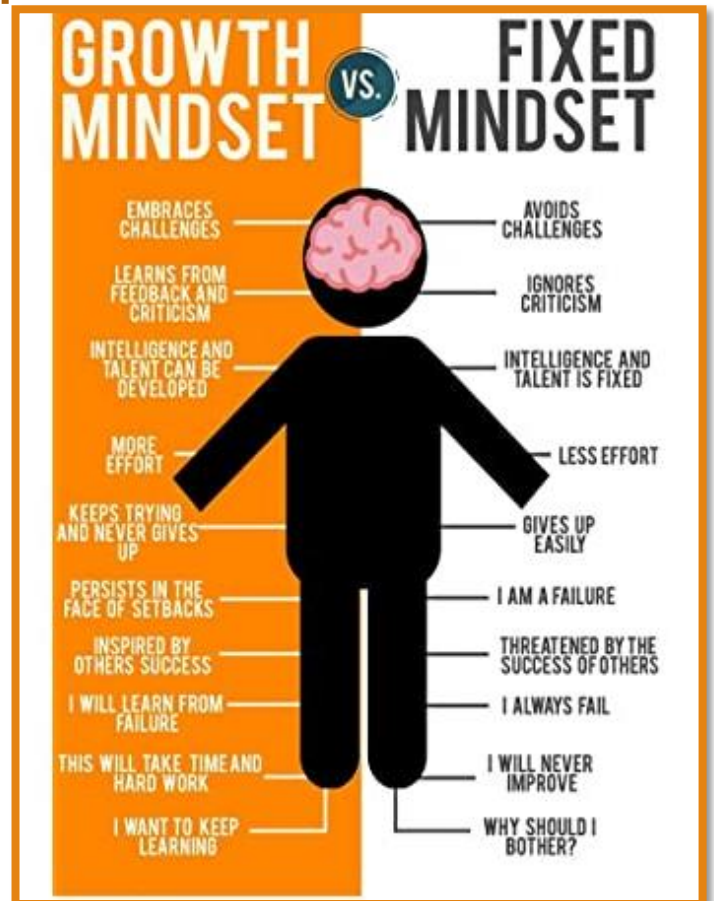
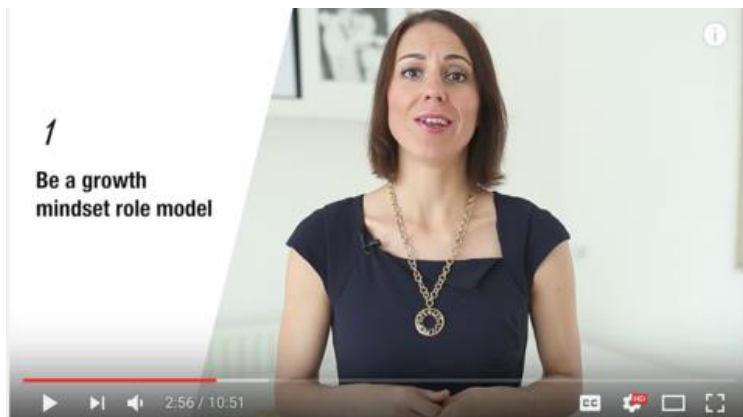

GROWTH MINDSET

TEACHING YOUR CHILD A GROWTH MINDSET

Here is a great video for parents created by Smart Parent Stories. It is about 11 min and it covers five main pillars behind teaching your child a growth mindset:

1. Be a growth mindset role model
2. Praise the process, not the result
3. Teach your kids about the brain
4. Encourage your kids to take the hard route
5. Stretch your kids capability



ECRA STUDENT DAILY COVID-19 QUESTIONNAIRE (if you chose in-person learning)



Each day before sending your child to school, please review the following questions regarding your child's health.

If you answer yes to any of the questions:

Please do not send your child to school. Contact a medical provider or call the COVID Hotline at 855-600-3453, then call the health office at ECRA.

Questions for ECRA Students Before They Go to School

1. Does your child currently have a temperature of over 100.4 degrees?
2. In the past 24 hours, has your child experienced:
 - o Sore throat, runny nose, congestion
 - o New frequent, dry cough (for students with documented chronic allergies/asthma, a change in baseline cough)
 - o Shortness of breath or difficulty breathing
 - o Diarrhea, vomiting
 - o Loss of taste or smell
 - o New onset of headache
 - o Fatigue or muscle or body aches
3. Has your child recently been in close contact with anyone who has exhibited any of these symptoms?
4. Has your child recently been in contact with anyone who has tested positive for COVID-19?
5. Is anyone in the household waiting for COVID-19 test results? (Routine surveillance testing not included)

Reviewing these questions daily and making good decisions can help us prevent the spread of COVID-19.

MATERIALS PICK UP




Materials pickup for remote students will be held every Friday between 1:30 and 4:30. Please contact the school if you plan to pick up materials so we can be prepared for your arrival.
